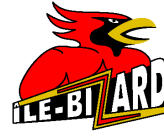

On the bases of those qualities, as a parent, I acknowledge that the children will be classified according to the preseason selections established by the association.

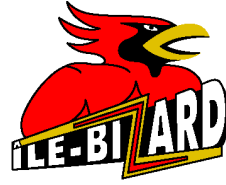
